A copy of the juristic person certificate issued by the Ministry of Commerce issued within the past 3 months, with the original signatures of directors authorized to represent the company or their representatives following the company's conditions. 2. A copy of Thai national I.D. Card of directors who are authorized to represent the company, certified true with original signatures.

A copy of the company's registration certificate issued by the regulating government agency. 2. A copy of the juristic person's affidavit of incorporation showing directors authorized to bind the company and conditions relating thereto, showing the company's headquarters location and authority of the signatory. This affidavit must be issued by an authorized official of the juristic person or the government agency having jurisdiction over the juristic person. 3. Certified true by notary public or agency of the government having jurisdiction where the document was executed. 2. Certified within the past 3 months before being submitted to company. 4. Translated into English if necessary.
